A motion was made to suspend the reading of the Meeting Minutes from January 13, 2013 by Tricia McCarrick Seconded by Mr. Clark A motion was made to approve the 1/13/13 meeting minutes by Wes Mariner and seconded by Tom Tomasheski.

- Ordering supplies -- softballs, rule books, scorebooks. GHS will approach board/division leaders for approval of using stockpile of softballs GHS has. OGSO has switched to the vinyl ball.
- Rule Changes:

 - Class D metal cleats, no chinstraps necessary.
 - Discussion of mandatory facemasks, decided it will not be implemented but strongly encouraged.

- Meeting was had 2/7 to discuss the 2013 concession stand operations.
- It has been requested that GHS is given one contact per team (can not be a coach) this person will be responsible for coordinating their team for their assigned dates of coverage and attending a mandatory training prior to the start of the season.
- The Food Permit needs renewed. Wes Mariner made a motion to get this paid and Mr. Miscuda seconded it.

Old Business

- Head Umpire Position still needs filled George Bates advised if no one else is interested he will return.
- Field Maintenance Randy Moore was asked if Riley Moore would be interested in returning to the do the field prep this year for Grafton Reservoir Park and the Belden fields. Randy will advise once he speaks to Riley.
- The old concession stand that was donated to Midview High School for the south side of the stadium still hasn't been moved due to some challenges in moving it.

New Business

- Co-Chair Boys Personnel Position for 2013. A motion was made to have Scot Kardos (former Belden Boys Personnel Director) to be a Co-Chair with Wes Mariner. Motion was made by Mr. Miscuda and seconded by Chris Miscuda. It was also noted that Grafton will still only have one (1) vote at the county level.

- We will need to put a bid in to host the Boys Tournaments by March after our next meeting. Everyone needs to think about this and what it entails and we will discuss at the next meeting.
- It was requested another newsletter be done (only it would not be printed and mailed). It will be emailed to the coaches (they will be asked to forward it to the families) and posted on the website. If anyone would like to help put it together or have any suggestions on what we should mention please let Rhonda know.
- An insurance payment was due to Westfield, it was decided more information would be needed due to the Belden/Grafton merger. A motion was made by Tim Shevel and 2nd by Rhonda Mueller to pay the bill once Tricia McCarrick & Mr. Clark have gathered all the information they need to bring the policy up to date to include all assets.
- Ashley to follow up with Tom Tablet to get the Belden Boosters termination letter and get an inventory of the assets being transferred to Grafton.
